AMENDMENT TO THE AMENDED AND RESTATED BY-LAWS OF BAYTREE COMMUNITY ASSOCIATION, INC.

The Amended and Restated By-laws of Baytree Community Association, Inc., which were duly adopted on November 18, 2002 and again on August 9, 2005, are hereby amended as follows (additions are indicated by underlining; deletions are indicated by strike-throughs):

Article VI, Section 3. Qualifications for Election. All Directors shall be Members of good standing within the Community and shall not have to be a also hold office as a Neighborhood Voting Member-, Alternate Voting Member, or CDD Board Member. Once elected or appointed as a Director, Members serving as a Voting Member or Alternate Voting Member must resign as Neighborhood Voting Members.

A Voting Member or Alternate Voting Member, when nominated for election as a Director shall recuse themselves from voting in the general election. No more than two Directors shall be from any one Neighborhood.

There shall be no more than one household.
